THE IMPORTANCE OF CRITICAL THINKING AND ANALYSIS

ACTIVE LEARNING AND KNOWLEDGE APPLICATION

KNOWLEDGE BECOMES TRULY IMPACTFUL WHEN IT IS ACTIVELY LEARNED AND APPLIED. THIS MEANS MOVING BEYOND PASSIVE READING OR LISTENING TO ACTIVELY ENGAGING WITH THE MATERIAL. IT FORMS THE BEDROCK UPON WHICH FURTHER LEARNING AND ANALYSIS ARE BUILT.

PROCEDURAL AND INSTRUCTIONAL KNOWLEDGE

DEVELOPING A HABIT OF INQUIRY

MAKING KNOWLEDGE SEEKING A HABIT INVOLVES ACTIVELY INTEGRATING IT INTO DAILY LIFE. CLARIFICATION LIES IN RECOGNIZING THEM AS TOOLS FOR DEEPER COMPREHENSION AND APPLICATION, NOT JUST PASSIVE INFORMATION RETRIEVAL.

HOW ARE 'KNOWLEDGE MATTERS ANSWERS' EVOLVING WITH THE RISE OF AI AND LARGE LANGUAGE MODELS?

AI AND LLMs ARE SIGNIFICANTLY TRANSFORMING HOW 'KNOWLEDGE MATTERS ANSWERS' ARE GENERATED AND ACCESSED. WHAT ARE THE ETHICAL CONSIDERATIONS SURROUNDING THE RELIANCE ON 'KNOWLEDGE MATTERS ANSWERS' IN EDUCATIONAL SETTINGS?

But is there more involved, perhaps something like nurturing in students a desire to probe deeper into the workings of things? Or developing a capacity to explain why things work the way they do? Our conceptions of what genuine knowing is serve as guides to what we think the goal of education is, and they tell us how to “build a student.” However, as it turns out, there are

multiple conceptions of what knowing truly involves, and these conceptions tend to be different for different sets of education stakeholders such as parents and their children, school administrators, and educational researchers.
