REDEMPTION FROM TAX LIEN SALES

MORTGAGE REDEMPTION RIGHTS

IN SOME CASES, EVEN BEFORE A FULL FORECLOSURE PROCEEDING IS COMPLETED, A BORROWER MIGHT BE ABLE TO REDEEM THEIR MORTGAGE BY PAYING THE ENTIRE OUTSTANDING BALANCE, PLUS FEES, TO STOP THE FORECLOSURE PROCESS. THIS IS OFTEN REFERRED TO AS REDEMPTION PRIOR TO SALE.

THE REDEMPTION PROCESS EXPLAINED

LEGAL CONSIDERATIONS AND VARIATIONS
