FOR OFFICERS, THIS WOULD INCLUDE THEIR NAME AND COMMISSIONED RANK; FOR ENLISTED PERSONNEL, THEIR NAME AND ENLISTED RATING ARE RECORDED. ACCURACY IN THESE DETAILS IS PARAMOUNT FOR LINKING THE REPORT TO INDIVIDUAL PERSONNEL RECORDS.

DATES AND TIMES OF ATTENDANCE

A CRITICAL ASPECT OF THE MUSTER REPORT IS THE TEMPORAL ELEMENT. THE REPORT WILL SPECIFY THE DATE AND, IN MANY CASES, THE TIME FOR WHICH THE MUSTER IS BEING TAKEN. DUTY STATUS AND REMARKS

BEYOND SIMPLY LISTING WHO WAS PRESENT, NAVY MUSTER REPORTS OFTEN INCLUDE INFORMATION ABOUT EACH INDIVIDUAL'S DUTY STATUS. THIS COULD INDICATE WHETHER THEY WERE ON DUTY, ON LEAVE, ON LIBERTY, UNDER MEDICAL OBSERVATION, OR ASSIGNED TO OTHER SPECIFIC DUTIES. ADDITIONAL REMARKS MIGHT BE INCLUDED TO EXPLAIN ANY ANOMALIES OR SPECIAL

CIRCUMSTANCES RELATED TO AN INDIVIDUAL'S PRESENCE OR ABSENCE. THESE REMARKS ADD CONTEXT AND DEPTH TO THE REPORT, MAKING IT MORE INFORMATIVE FOR ADMINISTRATIVE AND OPERATIONAL PURPOSES.

SHIP OR COMMAND INFORMATION

EVERY NAVY MUSTER REPORT IS ASSOCIATED WITH A SPECIFIC SHIP, STATION, OR UNIT. THE REPORT WILL CLEARLY IDENTIFY THE NAME OF THE VESSEL OR COMMAND, ITS HULL NUMBER IF APPLICABLE, AND THE COMMANDING OFFICER AT THE TIME OF THE MUSTER. THIS CONTEXT IS ESSENTIAL FOR UNDERSTANDING THE REPORT WITHIN ITS OPERATIONAL SETTING. IT HELPS TO LOCATE THE REPORT WITHIN THE BROADER ORGANIZATIONAL STRUCTURE OF THE NAVY AND TO CORRELATE IT WITH OTHER OPERATIONAL RECORDS.

HOW NAVY MUSTER REPORTS ARE GENERATED

THE ROLE OF THE OFFICER OF THE DECK

THE OFFICER OF THE DECK (OOD) TRADITIONALLY PLAYS A SIGNIFICANT ROLE IN THE MUSTER PROCESS, PARTICULARLY WHEN THE SHIP IS UNDERWAY OR IN PORT AT NIGHT. THE OOD IS RESPONSIBLE FOR MAINTAINING THE SHIP'S LOG, WHICH INCLUDES RECORDING THE MUSTER. THEY ENSURE THAT THE MUSTER IS CONDUCTED ACCURATELY AND THAT ALL PERSONNEL PRESENT ARE ACCOUNTED FOR. THEIR DIRECT SUPERVISION OF THE PROCESS HELPS TO MAINTAIN THE INTEGRITY OF THE MUSTER REPORT.

COMPILATION AND SUBMISSION

Once the physical muster is completed, the gathered information is compiled into a formal report. This involves documenting each sailor's presence, status, and any relevant remarks. This was all made available to the author of this monograph. The interviews conducted during 1971-1972, 29 in number, form a valuable archive of personal experiences of these pioneer women Marines. They have been used to supplement the official records which are sparse and elusive. Muster rolls of the time were checked exhaustively in compiling a roster of women who served, but it proved impossible to discover all the names making up the 305 women who were enlisted as Marine .Corps Reserve (F). Much information was gleaned from contemporary magazine and newspaper articles, particularly from Leatherneck, Marine Corps Gazette, The Marine Magazine, Recruiter's Bulletin, and the New York and Washington daily

newspapers. A small but useful collection of Women Marine memorabilia, including photographs, letters, and clippings, was donated by various individuals as a result of publicity about the project.
