- SCHIZOPHRENIA (Sc)
- HYPOMANIA (Ma)
- SOCIAL INTROVERSION (Si)

ELEVATED SCORES ON THESE SCALES SUGGEST THE PRESENCE OF CERTAIN PERSONALITY CHARACTERISTICS OR PSYCHOLOGICAL PROBLEMS. HOWEVER, IT IS ESSENTIAL TO REMEMBER THAT THESE SCALES ARE NOT DIAGNOSTIC CATEGORIES BUT RATHER INDICATORS OF PSYCHOLOGICAL DISTRESS OR MALADAPTIVE PATTERNS.

SUPPLEMENTARY AND CONTENT SCALES

BEYOND THE VALIDITY AND CLINICAL SCALES, THE MMPI-2 ALSO INCLUDES NUMEROUS SUPPLEMENTARY SCALES AND CONTENT SCALES. WHAT ARE THE MAIN DIFFERENCES BETWEEN THE MMPI-2 AND THE MMPI-2-RF?

THE MMPI-2-RF (RESTRUCTURED FORM) IS A SHORTER, UPDATED VERSION OF THE MMPI-2. IT USES A DIFFERENT ITEM POOL

AND A NEW SET OF SCALES TO IMPROVE EFFICIENCY AND CLINICAL RELEVANCE, WHILE MAINTAINING THE CORE PSYCHOMETRIC PROPERTIES OF THE ORIGINAL MMPI-2.

WHAT DOES THE MMPI-2 MEASURE?
