bureaucracies and lobbies, and finally, individuals that all possess separate personal interests as they participate in the overall system.⁵ Some academics choose to distinguish between national interests (interests involved in the external relations of the actor) and public interests (interests related within the boundaries of the actor).⁶ For purposes of this essay, given the closing gap between the influence of external and internal issues in the 21st century international system brought about by the associated components of a rapidly globalized world, there will be no distinction made between external and internal interests. In effect, they all fall under the concept of the national interest. There is a generally accepted consensus among academics that interests are designed to be of value to the entity or actor responsible for determining the interest for itself. This could include 4 those interests that are intended to be a standard of conduct or a state of affairs worthy of achievement by virtue of its universal moral value.⁷ However, there is less agreement over the question of whether all nation-state interests are enduring, politically bi-partisan, permanent conditions that represent core interests that transcend changes in government,⁸ in contrast to those interests that may be altered over time and or respond to change in the international system.
