As for the rest of the book: Sacco turns his pitiless pen on all strata of Rock 'n' Roll, from old rockers (two stories on the Rolling Stones) to new; from salacious gossip to how-to (Woodstock in your Own Home); from portraits of typical rock creatures (Record Producer, The Musician Who Wanted to Save the World, The Rock Journalist) to self-deprecating autobiographical stories.
