He finds, among other things, that: - Ancient Israel, just like Punt, was a renowned source of frankincense. - Egyptian documents, generally ignored in academic circles, unequivocally place Punt in the region of Syria/Palestine. - The goddess Hathor was known as the 'Lady of Punt,' but she was also known as the 'lady of Byblos'. - The Egyptians claimed to be of Puntite origin, but Jewish and Phoenician legends claimed that the Egyptians came from their part of the world, and the Phoenicians named Misor - almost certainly the same as Osiris - as the Phoenician hero who founded the Nile Kingdom.
