COACHES AND OFFICIALS ARE RESPONSIBLE FOR ADHERING TO AND ENFORCING THESE GUIDELINES DURING ALL SANCTIONED EVENTS. THE RULES ARE UPDATED PERIODICALLY TO REFLECT CURRENT BEST PRACTICES IN SPORTS MEDICINE AND ATHLETE SAFETY.

PURPOSE AND SCOPE

PITCH COUNT LIMITS

MAXIMUM PITCHES PER GAME

THE TSSAA ESTABLISHES A MAXIMUM NUMBER OF PITCHES A PITCHER CAN THROW IN A SINGLE GAME. WHILE SPECIFIC NUMBERS MAY VARY BY DIVISION AND AGE, TYPICAL PITCH COUNT CAPS RANGE BETWEEN 85 TO 105 PITCHES PER GAME. PITCH COUNT TRACKING

- 1-20 PITCHES: NO REST DAYS REQUIRED
- 21-35 PITCHES: 1 DAY OF REST
- 36-50 PITCHES: 2 DAYS OF REST
- 51-65 PITCHES: 3 DAYS OF REST
- 66 OR MORE PITCHES: 4 DAYS OF REST

THESE REST PERIODS HELP PROTECT YOUNG ATHLETES FROM CUMULATIVE STRESS ON THEIR THROWING ARMS.

CONCURRENT OR OVERLAPPING GAMES

THE REST REQUIREMENTS APPLY REGARDLESS OF WHETHER THE PITCHING OCCURRED IN A SINGLE GAME OR MULTIPLE GAMES PLAYED ON THE SAME DAY. IF A PITCHER THROWS IN MORE THAN ONE GAME WITHIN A 24-HOUR PERIOD, THE PITCH COUNTS ARE COMBINED TO DETERMINE THE NECESSARY REST PERIOD. COACHES MUST CAREFULLY MANAGE PITCHER USAGE TO COMPLY WITH THESE REST MANDATES AND AVOID VIOLATIONS.

PITCHER ELIGIBILITY AND REPORTING
