COMPONENTS OF THE ARMY DRESS BLUES SETUP

SHOES AND BELT

FOOTWEAR FOR THE DRESS BLUES SETUP CONSISTS OF HIGHLY POLISHED BLACK LEATHER SHOES, USUALLY OF THE OXFORD OR DRESS SHOE STYLE. AR 385-10 prescribes DA policies, responsibilities, and administrative procedures and funding for protective clothing and equipment. In accordance with chapter 45, section 771, title 10, United States Code (10 USC 771), no person except a member of the U.S. Army may wear the uniform, or a distinctive part of the uniform of the U.S. Army unless otherwise authorized by law. Additionally, no person except a member of the U.S. Army may wear a uniform, any part of which is similar to a distinctive part of the U.S. Army uniform. This includes the distinctive uniforms and uniform items listed in paragraph 1-12 of this regulation.
